Subject – Special Examination – Even Semester 2020

With reference to i) *Guidelines on conduct of Final Semester Examinations by “Take Home Examination” mode in view of COVID-19 pandemic*, vide notification – **86/2020**, dated 27th August 2020 and ii) *Guidelines for End Semester Examinations, 2020 for current UG (2nd and 4th Semesters); PG (2nd Semester) and other Intermediate semesters of various programme in view of COVID-19 pandemic and subsequent lockdown*, vide Notification – **68/2020**, dated 19th June 2020, there shall be **Special Examination for Even Semester 2020**, which shall be considered as regular attempt and not as back paper, for those students who wish to improve their results or who failed to submit examination form/pay examination fees of Even Semester 2020.

In view of the same, it is being notified that -

1. The Special End Term Examination shall be held in **March 2021** along with the regular examination for Odd Semester 2020.
2. Students who wish to apply for the special examination must compulsorily submit the Online Examination Form by **28th December 2020**. No applications will be accepted after the deadline.


